**Members of the International Plant
Protection Convention (IPPC)**

The State Service of Ukraine on Food Safety and Consumer Protection (hereinafter – the SSUFSCP) presents its compliments and informs you of the following.

Starting from 01.05.2025, Ukraine will introduce the issuance of phytosanitary certificates and phytosanitary certificates for re-export (hereinafter – certificates) in electronic form (ePhyto) (samples are attached), taking into account the requirements of the International Plant Protection Convention and the International Standard for Phytosanitary Measures No. 12.

Such certificates will contain a QR code in the upper right part and a number in the following format: № UA/13/XX-6XXX/AA-XXXXXXX and will be printed on A4 format sheets, signed and sealed with the triangular stamp of the state phytosanitary inspector of the relevant main administration of the SSUFSCP in the region or in Kyiv.

At the same time, the state phytosanitary inspectors of the main administrations of the SSUFSCP in the regions and in Kyiv for the transition period will continue to issue certificates for shipments of regulated articles in paper form on secure numbered forms in the format used before 01.05.2025 (samples are attached). You will be additionally notified of the end of the transition period.
