Increase in pest reporting

According the IPPC Convention the Contracting Parties cooperate in the exchange of information on plant pests, particularly the reporting of the occurrence, outbreak or spread of pests that may be of immediate or potential danger (Article IV.2b & VIII.1a). The IPPC Contracting Parties agreed to carry out such pest reporting via the International Phytosanitary Portal as the preferred mechanism for such action.

To date, 2015 has seen a welcome increase in the IPPC pest reporting. Out of 479 pest reports available on the IPP since 2005, 136 have been provided by the CPs as new or update reports since the beginning of this year (1 January – 7 October 2015). That constitutes 28% of all pest reporting available on the IPP. Especially busy months in 2015 were June (67 pest reports), October (19 pest reports) and February (12 pest reports). In comparison, during the year 2014 53 pest reports were provided by the CPs, while 45 pest reports were made available in 2013.

The table shows the most active countries in 2015. It is also worth noting that in 2015 some countries reported for the first time: Guyana, the Republic of Korea and Rwanda.

The Secretariat welcomes this increase in pest reporting by CPs and hopes this positive trend will continue

and expand. Some of the increase in pest reporting might be due to the launch of the new version of the IPP website in February 2015 which made data entry easier for OCPs and IPP editors. Further guidance on pest reporting will be provided after feedback has been received from all IPPC Regional Workshops.

Pest reporting – cooperation with RPPOs

One of the main responsibilities of an NPPO is conducting the surveillance of growing plants, including both areas under cultivation (inter alia fields, plantations, nurseries, gardens, greenhouses and laboratories) and wild flora, and of plants and plant products in storage or in transportation. Then one of the main responsibilities of OCPs is reporting the occurrence, outbreak and spread of pests, and of controlling those pests. As agreed by CPM, the preferred mechanism for such pest reporting is via the IPP website directly by OCPs or appointed IPP editors.

To facilitate this process, more recently CPM-6 recommended that RPPOs should:

- actively encourage members to improve on meeting their reporting obligations,
- develop mechanisms whereby countries that wish to report through RPPOs can do so within the framework established by the Secretariat,
- develop electronic systems to undertake such reporting on behalf of countries that are compliant with the IPP and will allow the automation of the process.

CPs can choose to undertake the pest reporting via their RPPO provided the RPPO is technically able to undertake this work and agrees to do this. However, as legal responsibility for pest reporting remains with the NPPOs, a form for CPs to provide authority to the RPPO to undertake pest reporting on their behalf is available here. Please note that this form was updated in March 2015 and is available in English, French, Spanish, Russian and Arabic. Although the Secretariat is able to receive pest reports from RPPOs with agreed and compatible protocols, this option remains under development but is nearing finalization. Therefore, it needs to be stressed that at present, CPs remain responsible for direct pest reporting to the IPPC.

The IPPC Secretariat has been working with the European and Mediterranean Plant Protection Organization (EPPO) and more recently with the Pacific Plant Protection Organisation (PPPO) to achieve this objective. Discussions have also been ongoing with the North America Plant Protection Organization (NAPPO).

Did you know?

Art. VIII 1(a) of the IPPC states that the reporting of pests will be undertaken by CPs "... in accordance with such procedures as may be established by the Commission ...". By publishing pest reports on the public IPP, CPs meet all their reporting requirements at once in this way.
