

Pest reporting and pest surveillance

Pest reporting is frequently the product of pest surveillance which is one of the responsibilities of a NPPO of an IPPC CP. In particular, pest surveillance should cover:

- growing plants, including both areas under cultivation (inter alia fields, plantations, nurseries, gardens, greenhouses and laboratories) and wild flora,
- plants and plant products in storage or in transportation

with the object of reporting the occurrence, outbreak and spread of pests, and of controlling those pests. The IPPC IRSS has spent considerable efforts in recent years addressing national surveillance needs, the relevant IPPC standards and implementations challenges.

Given the importance of surveillance to the IPPC, an IPPC Expert Working Group (EWG) for the Revision of the ISPM No. 6: Guidelines for Surveillance met in October in New Zealand. The EWG analyzed, among others, the findings from the IPPC's IRSS questionnaire, reviewed the issues discussed at the Global Symposium on Plant Pest Surveillance, and considered the content of the IPPC draft manual on surveillance. The EWG proposed to add new sections to the ISPM to explain more clearly how and why to perform general and specific surveillance, and details were added with the aim to provide guidance to NPPOs on the establishment of dynamic and efficient pest surveillance systems. The revised draft ISPM will be presented to the SC in May 2016 for possible member consultation in 2016.

The outcome of discussions will be presented to CPM-11 (2016) at a side session on "standard setting and surveillance".

Reporting on emergency action

The IPPC Convention text stipulates an obligation to report emergency action (Art VII paragraph 6):

Nothing (...) shall prevent any contracting party from taking appropriate emergency action on the detection of a pest posing a potential threat to its territories or the report of such a detection. (...). The action taken shall be immediately reported to contracting parties concerned, the Secretary, and any regional plant protection organization of which the contracting party is a member.



According to ISPM No. 5:

- emergency action: a prompt phytosanitary action undertaken in a new or unexpected phytosanitary situation;
- phytosanitary action: an official operation, such as inspection, testing, surveillance or treatment, undertaken to implement phytosanitary measures.




Since the year 2002 only 23 reports on emergency action were made available by 16 countries on the IPP. To date, 6 reports have been reported since the beginning of 2015, while no reports at all were made in 2014. At the same time, according to an analysis of pest reports available on the IPP – about 30% of pest reports out of 479 uploaded by countries have elements of emergency action embedded in them.

During the NROAG meeting in July 2014 the underreporting of emergency action was one of the subjects discussed. One of the short term goals established by NROAG in regard to an emergency actions was to request a study for IRSS to explore constraints to meet emergency action reporting. However, in June 2015 during the Bureau meeting it was decided that such an analysis should be done within the NRO framework.

Therefore, a questionnaire to explore constraints to meet emergency action reporting prepared by the Secretariat with advice from NROAG will soon be sent to the CPs. Having collected the responses, the Secretariat will prepare the summary analysis with the aim of having it available before CPM-11 2016. OCPs are kindly asked to participate in that survey. The more response the Secretariat will receive from CPs the more accurate and useful the analysis will be.
