ISPM 15 Symbol registration – progress

Introduction

[1] CPM-10 noted the progress in ISPM 15 symbol registration and encouraged contracting parties to pursue registration and renewals of registration.

Progress and Current Status¹

- [2] In 2014, the IPPC Secretariat initiated new registrations for 17 countries which were identified as the first group based on the prioritization criteria. Prioritization criteria include considerations of legal and trade-related indicators and commitments by countries to reimburse registration costs. Total allocated budget for this purpose was USD 65,000 and is still being used. IPPC Secretariat is working closely with FAO Legal office in monitoring the work of legal companies that are contracted to file registration applications. Other relevant progress includes:
- [3] Letter to Ministers. In order to raise awareness about the importance of protecting the symbol and assist the NPPOs in their interaction with their respective government, a letter was sent (some letters are pending) to the responsible Minister in each country, explaining the purpose of registration and highlighting the need for political and financial support in registering or renewing the registration. Since CPM-10, IPPC Secretariat has been working intensely to answer all the questions raised by contracting parties regarding the letter on how they can contribute to the registration process.
- [4] Registration renewal cost reimbursement letters. Another letter was earlier sent to the NPPOs providing information on the reimbursement procedures for compensating the costs of registration renewals done in 2013. Many countries expressed their willingness to reimburse such costs. Many countries already reimbursed the costs to the IPPC Secretariat.
- [5] The Q&A information was posted on the IPP portal 2 .

The next steps include:

- [6] Second round of new registrations. The second group of countries where the new registration will be initiated in late 2015 will be identified based on the prioritization criteria within the allocated budget, as done in 2014. In late 2015, IPPC Secretariat in collaboration with the FAO Legal office will initiate second round of first registrations in additional 15-20 countries. If countries want to be prioritized in registration, they should express the interest to reimburse the cost of registration by sending an email to ippc@fao.org.
- [7] Unless there are unexpected problems (such as legal issues raised by certain entities that have already registered the symbol without consulting FAO which might delay the process of registration), the remaining registration renewals and new registrations will be dealt with by the end of 2017 under the total agreed budget of USD 350,000 (in the five years period 2013-2017). There are 66 counties where new registrations will be initiated in the above-mentioned timeframe. The contracts with the two trademark firms selected by FAO to carry out the registration process on its behalf will expire in September, 2018. Towards the end of the period, the budget may be revised for adjustment, as appropriate.
