SPM IMPEMETANTION

- Ministry of Agriculture and Rural Devenlopiment is a authority responsible for a implementation of Sanitary Phitosanitary Measures through the National Directorate of Agriculture livestock and foresty, (**Plant Protection Division NPPO**), Vetarianary service.
