1. The CPM-8 (2013) amended the CPM Rules of Procedure, please refer to the link for further details¹
2. Rule II of the CPM Rules of Procedure makes clear that a person can only be elected to the Bureau if he/she is present at the session of the CPM where the election takes place. In addition, the person must have agreement from his/her head of delegation to be elected.
3. According to Rule IV of the Rules of Procedure for the CPM Bureau (Replacement of members), CPM- 12 (2017) needs to elect a replacement member for the Bureau from the Europe region, so that the election can be completed during CPM-12 (2017). Table 2 shows the name of the current CPM Bureau Replacement members.
4. All nominations should be submitted by each region through the mechanism established for each region or through the Chair of the FAO regional group. The deadline for submission of nominations to the IPPC Secretariat (ippc@fao.org) is 24 February 2017. Nominations should be accompanied by the signed Statement of Commitment, available on the IPP².
5. The CPM is invited to:
 - 1) *elect* a replacement member from the Europe region to the CPM Bureau.
