Phytosanitary legislation - overview

Statistics on **Phytosanitary legislation on the IPP** (data valid: 15 May 2017) The NRO Year of Phytosanitary legislation (April 2017 – March 2018)

In July 2014, during the first meeting of the National Reporting Obligations Advisory Group, it was agreed that every year would be dedicated to a different national reporting obligation.

The period up to CPM-10 in 2015 became the NRO Year of the IPPC Official Contact Point. The period up to CPM-11 (April 2015 / March 2016) became the NRO Year of the Organization of the NPPO. The period up to CPM-12 (April 2016 / March 2017) became the NRO Year of Pest reporting. All three campaigns raised awareness and contributed into the increased reporting in those areas by contracting parties.

Following a recommendation from the Capacity Development Committee, IPPC contracting parties agreed in April 2017, during CPM-12, to concentrate efforts on Phytosanitary legislation (requirements, restrictions and prohibitions). Therefore the period leading up to CPM-13 will become the NRO Year of Phytosanitary legislation (April 2017 to March 2018).

The "NROS UPDATE" will provide general information on the topic of phytosanitary legislation, related recommendations, advice for IPP editors and statistics. The objective is to increase general awareness of this NRO ensuring there is an increase in number and a better quality of reports uploaded by countries on the International Phytosanitary Portal.

Phytosanitary legislation - overview

National Reporting Obligation: Publish and transmit phytosanitary requirements, restrictions and prohibitions

References in the IPPC: Article VII.2(b):

Contracting parties shall, immediately upon their adoption, publish and transmit phytosanitary requirements, restrictions and prohibitions to any contracting party or parties that they believe may be directly affected by such measures.

Type of report: Basic = an obligation regardless of circumstances

Method of reporting: Public = reported via the International Phytosanitary Portal (www.ippc.int)

Responsible entity: IPPC contracting party

Receiving entity: Any contracting party or parties that contracting parties believe may be directly affected by such measures.

Languages (Article XIX of the IPPC):

- Art XIX 3 (b) sets out that cover notes giving bibliographical data on documents transmitted according to Article VII paragraph 2 (b) shall be in at least one of the official languages of FAO.
- Art XIX 3 (c) sets forth that information provided according to Article VII 2 (b) shall be in at least one of the official languages of FAO.

Reason for reporting:

• To facilitate safe and efficient international movement of plant, plant products and other regulated articles. To result in minimum impediment of international movement of plants, plant products and other regulated articles.
