The IPPC is an international treaty that applies to most nations involved with international trade in any commodity that could introduce a new plant pest into a new area; in other words, it is applicable to all trans-boundary movements of plants and plant products.

It is in the interest of all nations to be contracting parties to the Convention: membership means they can play an active part in developing international standards that help to protect their exported and imported goods.

Exchanging technical and official phytosanitary information is vital to the Convention's effective implementation. The IPPC Web site — the IPP — acts as a forum for information exchange, and parties and the IPPC Secretariat use it to meet IPPC reporting obligations by publishing documents or providing links to outside Web pages.

The Convention identifies certain types of information countries are required to report to other contracting parties, to the IPPC Secretariat and/or to RPPOs:

The IPPC Standards Committee (SC) and Secretariat in May 2016

The first session of the [Commission on Phytosanitary Measures \(CPM-1 \(2006\)\)](#) established the Standards Committee (SC). The SC consists of 25 members from each of the seven FAO regions. The current membership of the Standards Committee is posted below.

The SC is responsible for:

- overseeing the [IPPC Standard Setting Process](#)
- managing the development of [International Standards for Phytosanitary Measures \(ISPMs\)](#)
- providing guidance and oversight to the work of [Technical Panels \(TPs\)](#) and [Expert Working Groups \(EWGs\)](#)

The Standards Committee Working Group (SC-7)

Seven SC members (one from each region) are selected by the SC to form the SC Working Group (SC-7). The SC-7 supports the work of the SC in the detailed consideration of draft ISPMs and specifications.

The SC-7 is responsible for:

- examining all of the substantive comments (including proposed amendments) from [the first consultation on draft ISPMs](#), identified by the steward
- reviewing and revising draft ISPMs prepared by the stewards in response to comments and proposing revisions to the SC
- drafting SC responses to substantive comments not incorporated into the draft ISPM, as identified by the steward
- proposing which changes to draft ISPM should be considered further by the SC
- explaining the proposed revisions to draft ISPMs to the SC as required
- performing other functions regarding draft standards and specifications as directed by the SC

Implementation and Capacity Development Committee (IC)

At the twelfth session of the Commission on Phytosanitary Measures (CPM 12) it was agreed that a new International Plant Protection Convention (IPPC) subsidiary body - Implementation and Capacity Development Committee (IC), would be established to replace the current Capacity Development Committee.

The IC, under the guidance of CPM, will develop, monitor and oversee an integrated programme to strengthen the phytosanitary capacity of contracting parties to implement the IPPC and meet the strategic objectives as agreed by the CPM.

The scope of the IC includes:

- Identification and review of the baseline capacity and capability required by contracting parties to implement the IPPC.
- Analysis of issues constraining the effective implementation of the IPPC and development of innovative ways to address impediments.
- Development, facilitation and delivery of the implementation support programme to enable contracting parties to meet and surpass the baseline capacity and capability.
- Monitoring and evaluation of the efficacy and impact of implementation activities and reporting on progress which indicates the State of Plant Protection in the World.
- Oversight of dispute avoidance and settlement processes.
- Oversight of national reporting obligation processes.
- Working with the IPPC Secretariat, potential donors and the CPM to secure sustainable funding for its activities.
- Oversight of specific capacity development and implementation projects.

The IC is comprised of members from all regions who have expertise and experience in the fields of managing phytosanitary systems, capacity development, implementation and phytosanitary technical knowledge. The IC meets twice a year to address implementation and capacity development matters raised by CPM.

The Terms of Reference and Rules of Procedure for the IC are included below.

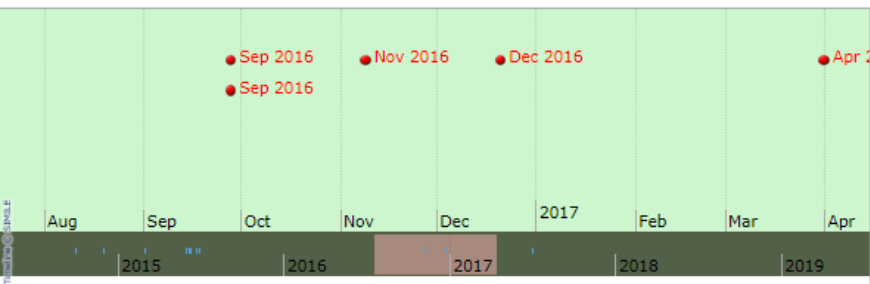

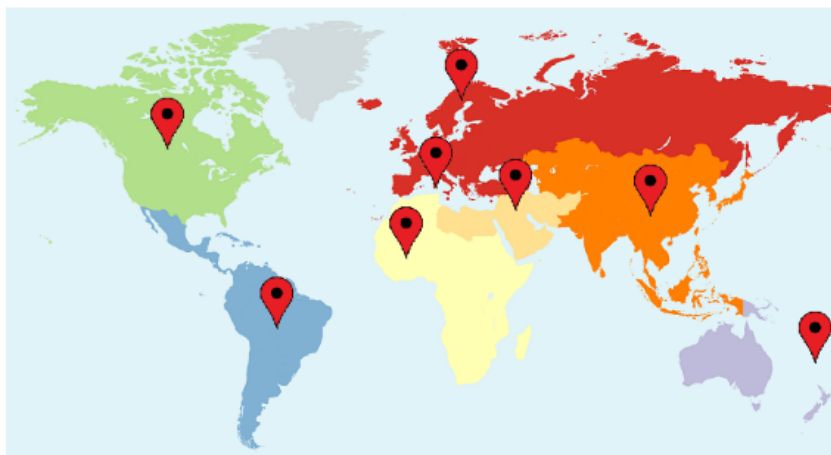

The organization of IPPC Regional Workshops are a priority for the IPPC Secretariat, as these workshops help participants understand the phytosanitary realities and challenges of each region. Participants and the Secretariat also receive input on how to better integrate these realities into the IPPC work plan.

In the past few years, the CPM decision to change the purpose of the IPPC Regional Workshops has been implemented. There are therefore 3 objectives to the IPPC Regional Workshop:

- to learn how to analyse draft ISPMs and to formulate productive comments using the available draft ISPMs for member consultation
- to build phytosanitary capacity and raise awareness on all activities related to the IPPC
- to exchange national experiences at the regional level.

Recently, the IPPC Regional Workshops have been re-organized as a forum for the exchange of ideas and feedback between NPPOs, RPPOs, FAO offices, cooperation institutions and the IPPC Secretariat. New alliances have been established with the organizers and more interactive activities have been included in the agenda. These new ways of operating allow the IPPC Secretariat to get a better understanding of NPPOs concerns, and to promote synergies and collaboration between all interested parties.

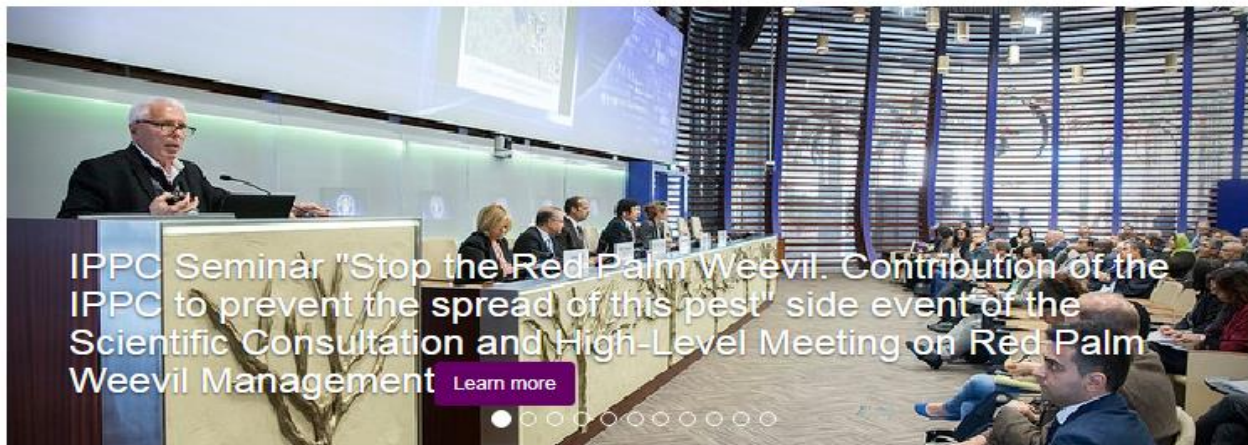
