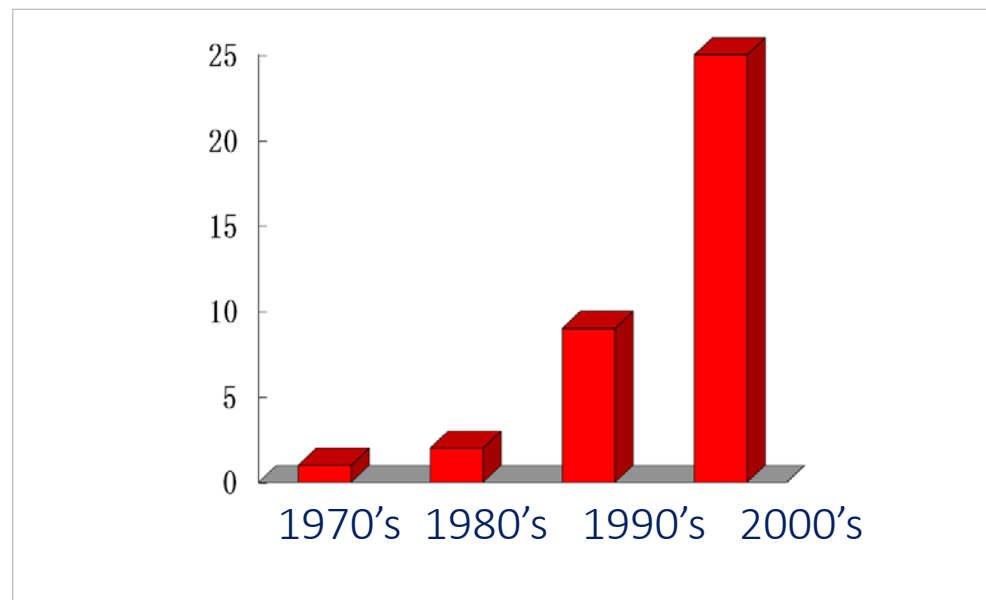

# 1. Demands for the IPPC: *Challenges at global level*

- Increased trade due to globalization
- Increased pest incidences due to Climate Change
- Increased risk of pest spread due to the global movement of tourists

No. of regulated pests increases by 1-2% annually in China



# 1. Demands for the IPPC: *Challenges at regional & national levels*

- *Current Situation:*

Increased demand for technical assistance to improve phytosanitary capacity of developing countries to implement the IPPC and its ISPMs (130 CPs, out of 183 , are developing countries)

- *Problems:*

Poor communication on the importance of plant health; Weak technical capacity; and lack of sufficient financial support

- *Solution:*

**Strengthen phytosanitary capacity of CPs to operate their national phytosanitary systems**





## 2. Relevance to FAO-China SSC:

### *Concept of FAO-China SSC programme*

- *Scope:*

Facilitate the exchange of resources, technologies, innovations and knowledge between developing countries to help build sustainable food systems and enhance their capacities to improve their own livelihoods

- *Objectives:*

Strengthen technical cooperation between China, developing countries and multilateral organizations

Increase capacity of developing countries at the institutional, national and regional levels



## 2. Relevance to FAO-China SSC: *Alignment with the IPPC*

- Enhance the implementation of the IPPC and its ISPMs through strengthening capacity and capability of the contracting parties
- Enhance safe trade
- Enhance the Communication and Partnership so as to increase the impact and resources of the IPPC



### 3. Core Activities and Budget: *Overall objectives & layout*

- *Overall objective:*

To increase the capacity of involved developing contracting parties to implement the IPPC and its ISPMs

- *Overall layout:*

The project duration - four years (2017-2020)

The total budget of 2,000,000 USD, with 500,000 USD allocated for each year

Four work packages covered



# 3. Core Activities and Budget:

## *Work package one*

- *Objective:*

Enhance capacity of developing CPs to implement IPPC and its standards through adoption and extension of China's experience and technology, including two major activities (with 45% of budget)

- *Activity one:*

Support four IPPC Regional Workshops and four IPPC Workshops on NROs in Asia, South-West Pacific, Central Asia & Eastern Europe, Near East, and Africa covering over 100 participants from more than 100 developing countries

- *Activity two:*

Organize two high-level technical training courses on emerging phytosanitary issues in China for 40 CPs





## 3. Core Activities and Budget: *Work package two*

- *Objective:*

Promote inter-regional cooperation for implementing IPPC and its standards to support Chinese Initiative on “One Belt & One Road”, including two main activities (20% of budget)

- *Activity one:*

Organize two IPPC-China Regional Symposium on development and perspective of “One Belt and One Road” in China (one for “Belt” countries and one for “Road” countries, covering over 40 developing CPs)

- *Activity two:*

Set up two Pilot Sites to demonstrate new plant health tech and products of China (one in East Europe for managing Colorado beetles on potatoes, and one in Asia for managing Solenoids mealybug on cotton)









### 3. Core Activities and Budget: *Work package three*

- *Objective:*

Promote HR cooperation among China, IPPC Secretariat and developing CPs (30% of the budget)

- *Activities:*

IPPC Secretariat utilizes the services of Chinese professional technical staff for short and/or long term consultancy support, visiting scientists or internships to facilitate coordination and collaboration among China, IPPC Secretariat and relevant developing CPs



### 3. Core Activities and Budget: *Work package four*

- *Objective:*

Support key plant health activities of the IPPC, such as IPPC annual themes towards 2020, at the global, regional and national levels, especially for “International Year of Plant Health” in 2020 (IYPH 2020) with 5% of the budget

- *Activities:*

Co-organize the relevant activities for communication and advocacy in particular for IPPC Themes at least once a year
