





- No price controls, auction, membership or licensing requirements for traders.
- Electronic application, onsite issuance, or ePhyto for phytosanitary certificates.
- Phytosanitary fee schedules are publicly available online, or in legislation.
- Efficient and affordable pershipment document requirements for agri-trade.


- Neither mandatory nor recommended prices apply
- Risk-based food safety inspections (notice, charges, penalties)
- Fee schedules are available at an enquiry point via telephone
- Risk-based phytosanitary inspections for export product



Findings –Per-shipment exports



➤ The cost to obtain <u>per-shipment export documents</u> is highest in South Asia and Sub-Saharan Africa


Note: Data on time to obtain per-shipment export documents are not available for Ghana, Haiti, Malaysia and Zimbabwe. Data on cost to obtain per-shipment export documents are not available for Liberia. These cases were excluded from the calculation of the averages by region.



Findings – Phytosanitary certificates



➤ It is cheaper and faster to obtain a <u>phytosanitary certificate</u> in countries that have <u>electronic processes</u> in place and that can conduct inspections and issue certificates <u>on-site</u>



Notes: Data on electronic application of phytosanitary certificates are not available for Egypt, Arab Rep., Senegal, Serbia, Spain, Sudan, Tajikistan, Turkey, Uganda, Ukraine and Uruguay. Data on on-site issuance of phytosanitary certificates are not available for Ghana and Sudan. These cases were excluded from the calculation of the averages.




- Lists of regulated pests available online or in legislation
- Pest database exists online (photos, treatments, etc.)
- Pest surveillance (Gov) and pest reporting (citizens) obligations apply
- Pest risk analysis (PRA) is required, available online
- Risk-based phytosanitary import inspections may be conducted

- Surveys (general and specific) are upto-date
- List of regulated pests is up-to-date
- Registration of pesticides (chemical vs. bio), online catalogue, postregistration surveillance






