

Phytosanitary legislation in numbers

Phytosanitary legislation (phytosanitary requirements/ restrictions/ prohibitions) is an NRO category with the second biggest number of reports. They constitute 27 % of all NRO reports made available by countries on the IPP. Only Pest reports are more prolific constituting 34% of all reports.

More importantly, the numbers of Phytosanitary legislation reports have been increasing in a stable way over the last 4 years. In the year 2014 IPPC Contact Points or their IPP editors uploaded 59 reports on the IPP; while in 2015 - 60 reports; and in 2016 - 58 reports. This year 48 reports on Phytosanitary legislation have been uploaded on the IPP by countries so far. Those reports make a 40 % increase in comparison to all previous years (2005-2013). 4 stable record years in a row has never happened before.

All IPPC Contact Points are welcome to check their reports regarding Phytosanitary legislation on the IPP and upload new reports in case they are missing or update existing reports.

Uploading Phytosanitary legislation reports on the IPP

In order to upload a new report regarding Phytosanitary legislation you need to follow the steps described below.

1. Log in to the IPP website.

2. Click on the button: "Edit Country Information"

3. In order to add a new report you need to click on the button: "Add new" next to "Legislation: Phytosanitary Requirements/Restrictions/Prohibitions".

National Reporting Obligations



Clicking on this button activates a form. This form opens enabling you to submit data.

4. When you have finished filling in the form save the data by clicking on the button: **"Submit"** at the bottom of the page.



Remember about this advice:

Before uploading a new report, check first whether a similar report already exists possibly with outdated information. It is preferable that you update the existing report first if possible.
