# Implementation & Capacity Development Topics

There are two broad categories of ICD topics:

- topics submitted through the 2018 Call for Topics: Standards and Implementation - there are currently 17 topics in this category
- legacy topics – include commitments of the IPPC Secretariat to the CPM or to donors that were agreed on prior to the formation of the IC - there are 15 topics in this category.

# Phytosanitary Systems – component pages

- Purpose – group together all relevant materials concerning specific Phytosanitary Systems to help contracting parties and other IPPC stakeholders locate and efficiently use these materials
- Example of a Phytosanitary System would be Pest Risk Analysis (PRA)
- The PRA Phytosanitary System component page in the IPP would include:
  - ISPMs 2, 11 and 21
  - All other ISPMs that pertain to parts of the PRA process – for example ISPM 32
  - Guides and training materials relevant to PRA
  - Contributed resources relevant to PRA

Contracting parties to the IPPC agree to promote the provision of technical assistance to other contracting parties with the objective of facilitating the implementation of the Convention. In particular, the [Convention](#) encourages support to developing countries in order to improve the effectiveness of their [National Plant Protection Organizations \(NPPOs\)](#) and increase the potential for them to realize the benefits of safe trade. The Convention also encourages participation in regional plant protection organizations as the basis for cooperation in achieving the aims of the IPPC at the regional level.

The Implementation and Capacity Development Committee (ICD) provides oversight to ICD activities delivered by the Implementation and Facilitation Unit (IFU) of the IPPC Secretariat.

In addition, the IFU supports [FAO technical cooperation programmes \(TCP\)](#) and phytosanitary projects through:

- Enhancing capacity and strengthening plant protection infrastructures of NPPOs
- Promoting dispute avoidance and
- Assisting contracting parties to update their plant health legislation
