Fifteenth Session Virtual Meeting, 16, 18 March and 1 April 2021 Adoption of International Standards for Phytosanitary Measures (ISPMs) Agenda item 9.2 Prepared by the IPPC Secretariat

I. Introduction

- 1. This document presents the drafts proposed by the Standards Committee (SC) for adoption as International Standards for Phytosanitary Measures (ISPMs) by the Commission on Phytosanitary Measures (CPM) on its fifteenth session. It also presents the diagnostic protocols that have been adopted by the SC on behalf of the CPM, as well as activities related to adopted standards.
- 2. Appendix 1: Recognition related to Standard Setting activities presents all the experts who participated in the development of the International Standards for Phytosanitary Measures (ISPMs) or Annexes to ISPMs, adopted by CPM-15 (2021) or diagnostic protocols noted by CPM-15 (2021). The SC would like the CPM to express gratitude to the drafting groups' experts for their active contribution to the development of these ISPMs.

II. Eleven draft ISPMs (including Annexes) are being recommended for adoption, presented in attachments 01-11, to this paper (CPM 2021/XX)

Draft ISPMs

3. Background information on the drafts can be found in the status boxes of each draft ISPM.

4. Comments received during the June-September 2019, and June-September 2020 consultations are posted on the International Phytosanitary Portal (IPP)¹.

5. Summaries of the discussions and reasons for the proposed revisions are in the reports of both the SC and the Standards Committee Working Group (SC-7), which are also posted on the IPP^{2.} However, due to COVID-19 pandemic, the SC-7 did not take place in 2020.

- 6. To streamline processing, the draft ISPMs are presented for adoption as unformatted texts with numbered paragraphs in separate files on IPP³. After adoption, they will be formatted for publication. The SC recommends the following eleven draft ISPMs to the CPM for adoption:
 - 1) CPM 2021/15_01: Draft Revision of ISPM 8: Determination of pest status in an area (2009-005);
 - 2) CPM 2021/15_02: Draft ISPM: Requirements for the use of modified atmosphere treatments as phytosanitary measures (2014-006);
 - 3) CPM 2021/15_03: Draft 2018 Amendments to ISPM 5: Glossary of phytosanitary terms (1994-001);
 - 4) CPM 2021/15_04: Draft ISPM: Requirements for NPPOs if authorizing entities to perform phytosanitary actions (2014-002);
 - 5) CPM 2021/15_05: Draft Annex to ISPM 28: Irradiation treatment for *Bactrocera dorsalis* (2017-015);
 - 6) CPM 2021/15_06: Draft Annex to ISPM 28: Cold treatment for *Ceratitis capitata* on *Prunus avium, Prunus domestica and Prunus persica* (2017-022A);
 - 7) CPM 2021/15_07: Draft Annex to ISPM 28: Cold treatment for *Bactrocera tryoni* on *Prunus avium, Prunus domestica* and *Prunus persica* (2017-022B);
 - 8) CPM 2021/15_08: Draft Annex to ISPM 28: Cold treatment for *Ceratitis capitata* on *Vitis vinifera* (2017-023A);
 - 9) CPM 2021/15_09: Draft Annex to ISPM 28: Cold treatment for *Bactrocera tryoni* on *Vitis vinifera* (2017-023B);
 - 10) CPM 2021/15_10: Draft Annex to ISPM 28: Irradiation treatment for *Carposina Sasakii* (2017-026);
 - 11) CPM 2021/15_11: Draft Annex to ISPM 28: Irradiation treatment for the genus Anastrepha (2017-031).

Objections (excluding diagnostic protocols)

- 7. Following the IPPC Standard setting procedure (Section 3.5 of the IPPC Procedure Manual for Standard Setting⁴), contracting parties may submit objections on draft ISPMs (including phytosanitary treatments) along with the technical justification and suggestions for improvement to the IPPC Secretariat (ippc@fao.org) no later than three weeks before the CPM-15 (2021) meeting. Concerned contracting parties should make every effort to seek agreement before the CPM session. The objection will be added to the CPM agenda, and the CPM will decide on a way forward.
- 8. If no objection is received, the CPM will adopt the ISPMs without discussion.
- 9. Objections must be submitted to the IPPC Secretariat (ippc@fao.org) no later than 22 February 2021, 12:00 (GMT+1), with confirmation of receipt by the Secretariat. Contracting parties should send an individual e-mail with relevant documents attached for each draft ISPM objected to along with the technical justification and suggestions for improvement to the draft ISPM. Should contracting parties wish to submit an objection, they should use the template available on the IPP⁵.

10. The Secretariat will post an additional CPM paper detailing the objections on the IPP as soon as possible upon receipt of an objection(s), and contracting parties will be notified via the IPP. Contracting parties are urged to review the objections immediately and make efforts to try to resolve the objection prior to CPM. Contracting parties are also reminded that minor editorials may be submitted to the Secretariat, and if there are other points of concern that do not warrant an objection, these can also be submitted to the Secretariat where they will be kept for consideration during a future revision of the ISPM.

11. In their November 2017 meeting, the SC invited the CPM Chairperson to allow sufficient time for the CPM to decide whether objections are accompanied by technical justification and suggestions for improvement of the draft ISPM.

III. Diagnostic protocols (Annexes to ISPM 27)

- 12. In January 2019, the draft diagnostic protocol (DP) for Bactrocera dorsalis (2006-026) was submitted to the 45-day DP notification period (05 January 2019 20 February 2019)⁶ for inclusion as Annex to ISPM 27 (Diagnostic protocols for regulated pests).
- 13. No further objections were submitted to the adoption of the draft DP; therefore, the following was adopted by the SC on behalf of the CPM and is available on the IPP^{7:}
 - 12) DP 29: Bactrocera dorsalis (2006-026).

IV. Noting translation adjustment to International Standards for Phytosanitary Measures adopted at CPM-14 (2019)

Introduction

- 14. CPM-5 (2010) adopted a Language Review Group (LRG) procedure to correct editorial errors in language versions of adopted ISPMs. CPM-12 (2017) adopted a change to the procedure⁸ allowing for the IPPC Secretariat to inform the CPM of which standards have been reviewed by an LRG, without presenting the actual standards in track changes, as was previously the case. This means that the LRG reviews to the standards will not be attached to this paper but will be published on the Adopted standards page of the International Phytosanitary Portal (IPP)⁹ as they will become available.
- 15. The IPPC Secretariat provides information on the establishment and process of LRG on the IPP^{10} .

Establishment of Language Review Groups (LRG)

- 16. A Coordinator is needed for the LRG for French, as for four consecutive years, the LRG for French has not reviewed any standards.
- 17. Currently, the acting LRG Coordinator for Russian has not been officially nominated. Nevertheless, the LRG for Russian is active and carrying out their assigned tasks.

Review of CPM-14 (2019) Adopted Standards

18. The Secretariat has received the two ISPMs adopted at CPM-14 (2019) and the diagnostic protocol (DP) adopted by the SC in August 2018, then noted by CPM-14 (2019) with proposed modifications, if any, from the Arabic, Chinese, Russian and Spanish LRGs. The Secretariat submitted these to FAO Translation services, which revised the proposed changes. For each language, the consensus was reached between the FAO Translation services and the LRG for all the proposed changes. The proposed changes were then included in the revised ISPMs by the IPPC Secretariat and published on IPP as they became available.

Co-publishing agreements for unofficial translations of ISPMs

- 19. The IPPC Secretariat, Standard Setting Unit (SSU), currently administers ten co-publishing agreements.
- 20. Co-publishers are reminded to seek information on adopted standards through the CPM reports or the IPP. MS Word files of adopted standards will be sent to the co-publishers upon request.
- 21. Any country or regional plant protection organization that would wish to sign a co-publishing agreement with FAO for the unofficial translation of ISPMs and other documents may find the necessary information on the IPP¹¹.
- 22. These reviewed ISPMs are posted on the Adopted Standards page of the IPP, replacing previous versions.

V. Decisions
