Confirmation of Membership and Potential Replacements for CPM Subsidiary Bodies - Implementation and Capacity Development Committee (IC) Membership

I. Introduction

To assist the CPM in addressing implementation and capacity development issues, CPM-12 (2017) established the Implementation and Capacity Development Committee $(IC)^1$ to provide overall strategies and to oversee some of the work in this area that is assigned to them by the CPM, as a consequence, the previous committee that carried out similar functions, the Capacity Development Committee, was dissolved.

II. IC Term of Reference Review

During the Bureau meeting of December 2018², the Bureau requested the Secretariat to work with FAO Legal Services to revise the IC Terms of Reference and Rules of Procedure (TOR and ROP) to make them clear and to align them with the Standards Committee TOR and ROP where appropriate.

Bureau agreed that the IC is composed of 12 members and also noted that the intent was to have seven regional representatives and five experts, which is now more clearly reflected in the revised IC TOR and ROP presented to CPM under agenda item 08.2 (CPM 2021/09)³. In addition, the Technical Consultation among Regional Plant Protection Organizations and the Standards Committee both select a representative for this Committee.

III. IC Nomination procedures

In December 2019, the IPPC Secretariat issued a Call⁴ for nominations for regional representatives and experts to be members (and alternate and replacement members) of the Implementation and Capacity Development Committee (IC). The Bureau member from each region was requested to establish a procedure for their region, following this procedure, they have submitted an IC member as their regional representative. In addition, the Bureau reviewed nominations of experts and selected five additional members based on the list of requirements and balance of skills. The Bureau in May 2020 reviewed all nominations and selected and appointed seven IC regional representatives, five IC experts and four alternative and replacement members.

Three regions were still missing alternate and replacement members, so to complete the IC Membership, the IPPC Secretariat issued a Call⁵ in December 2020 for alternate and replacement members for Asia, Near East and Latin America. For Asia, no nominations were submitted and the Bureau member agreed to leave this position vacant. For the Near East and Latin America and Caribbean region, the IPPC Secretariat only received one nomination for each of these regions. The Bureau member from each of these regions selected the nomination received for their regions alternate and replacement IC member.

IC Members and alternates serve for a term of three years renewable on acceptance of the Bureau.

The Bureau selected and appointed IC Members is as shown in the Appendix 1:

The CPM is invited to:

1. *confirm* the Implementation and Capacity Development Committee members, as well as alternative and replacement members as presented in the Appendix 1.
