## **1. Opening of the meeting**

### **1.1 Welcome by the IPPC Secretariat**

[1] IPPC Secretariat (hereafter referred to as “the secretariat”) opened virtual meeting of the Technical Panel for the Glossary (TPG) and welcomed all participants.

## **2. Meeting arrangements**

### **2.1 Selection of the chairperson**

[2] The TPG selected Beatriz MELCHO (Uruguay) as chairperson.

### **2.2 Selection of the rapporteur**

[3] The TPG selected Rajesh RAMARATHNAM (Canada) as rapporteur.

### **2.3 Adoption of the agenda**

[4] The TPG adopted the agenda (Appendix 1).

## **3. Administrative matters**

### **3.1 Documents list**

[5] The documents list is provided as Appendix 2 to this report.

### **3.2 Participants list**

[6] All members were present. IPPC Secretariat invited TPG members to provide any update regarding their contact details by email. The participants list is appended to this report as Appendix 3.

### **3.3 TPG membership**

[7] Ms OMAR’s term as a TPG member ended in 2022, and the TPG was invited to discuss whether they would recommend to the SC that her term be renewed. Ms OMAR confirmed her willingness to continue as a TPG member, and the TPG recommended the renewal of her membership to the SC.

[8] Ms BOUHOT-DELDUC’s term as a TPG member ends in 2023. The TPG discussed and agreed to recommend to the SC that her term be renewed. Ms BOUHOT-DELDUC confirmed her willingness to continue as a TPG member and will seek confirmation of support from her supervisor to submit statement of commitment.

## **4. Update and reports**

### **4.1 Previous meeting report of the TPG (December 2022)**

[9] The secretariat reminded that the report was sent for comments and review to the Chairperson and to the Rapporteur.

[10] The secretariat explained that some changes were made to the report as follows:

- added a footnote to remind that alternative definitions of “test” are archived in the TPG work area;
- draft 2022 amendments to ISPM 5 will be sent as working paper to SC-7, except the term “visual examination” which is submitted to SC in May 2023 for approval for first consultation;
- the paper “TPG work on consistency with ISPMs: achievements and status”, prepared by Mr NORDBO, was appended to the TPG December 2022 meeting report as well as to the TPG update for the SC meeting in May 2023; and

- the ink amendment to ISPM 5 in relation to the term “entry (of a consignment)” was appended to the TPG December 2022 meeting report.

- [11] In addition, Ms MELCHO and Mr NORDBO proposed changes to the revised version, which were then approved by the TPG.
- [12] Mr NORBO asked the secretariat how papers “TPG work on consistency with ISPMs: achievements and status” and “Consistency issues with ISPM 23” will be presented to the SC. The secretariat replied that the former paper will be introduced as annex to the TPG update, while the latter will be presented as a stand-alone paper.
- [13] The final version of the report is available on the IPP<sup>1</sup>.

## 5. 2022 draft amendments to ISPM 5 (*Glossary of phytosanitary terms*) (1994-001)

- [14] The TPG amended the status box and the text with editorial changes. Hence TPG added in the section “Introduction” the following phrase, “In addition, comments are only sought on the terms and definitions, not on the associated explanatory text”. The TPG also removed the reference to the Tables with detailed TPG replies to comments from the first consultation since they are not publicly available.
- [15] The TPG discussed if making TPG replies publicly available can help countries in understanding the proposed revisions.
- [16] One member proposed the SC could consider having the TPG replies to comments from consultation appended to the TPG reports, since both TPG and countries took time to reply and had an exchange of opinions. He asked the SC and the secretariat to consider this proposal.
- [17] Another member agreed with the proposal but reminded that the Technical Panels report to the SC, therefore the responsibility lies with the SC. He also highlighted that countries should go to SC members representing their regions and ask how comments have been addressed by the TPG steward.
- [18] The secretariat replied that this proposal could be brought to the attention of the SC-7 since one of the agenda point is the review of the Standard Setting Process (SSP).
- [19] The TPG:
- (1) *invited* the SC to send this proposal to the SC-7 for its consideration during the review of the Standard Setting Process (SSP).

### 5.1 2022 Draft Amendments to ISPM 5 (*Glossary of phytosanitary terms*) (1994-001): Terms to be submitted to the SC-7 in May 2023 for second (and third) consultation

- [20] The TPG finalized the work on terms such as phytosanitary action (2020-006); phytosanitary procedure (2020-007); surveillance (2020-009); general surveillance (2018-046); specific surveillance (2018-047); inspection (2017-005); test (2021-005); release (of a consignment) (2021-007) that were discussed in depth during TPG face to face meeting in Santiago.
- [21] The TPG amended the notes to SC-7 of the terms “release (of a consignment)” and “inspection” as presented below.
- “release (of a consignment)” (2021-007)**
- [22] The TPG added in the notes the phrase at the end of paragraph 43: “If SC-7 agrees with the proposal of TPG, this term should be removed from 2022 Amendments to ISPM 5 and included in SC November 2023 approval for adoption by CPM-18”.

#### **“inspection” (2017-005)**

[23] The TPG amended paragraph 50 in the notes, resulting as “[...] the TPG recommends that the SC-7 submits the revised definition of “inspection” to SC for approval for adoption by CPM-18. If SC-7 agrees with the proposal of TPG, this term should be removed from 2022 Amendments to ISPM 5 and included in SC November 2023 approval for adoption by CPM-18”.

[24] The same approach was taken for the amendment of paragraph 57, which now reads “The SC-7 May 2023 confirmed its support for the proposed revision and is now submitting the proposal to SC approval for adoption by CPM-18”.

[25] The TPG:

(2) *agreed* to the changes;

(3) *finalized* the draft 2022 amendments to ISPM 5, which will be presented to the SC-7.

## **6. 2023 draft amendments to ISPM 5 (*Glossary of phytosanitary terms*) (1994-001)**

### **6.1 Terms to be submitted to the SC in May 2023 for first consultation**

[26] Mr NORDBO and Ms MELCHO presented the several proposed changes to the document that were made based on discussion at TPG meeting in Santiago and email exchange among TPG members.

[27] The TPG added in the section “Introduction” the phrase, “In addition, comments are only sought on the terms and definitions, not on the associated explanatory text”.

#### ***“emerging pest” (2018-003)***

[28] Mr NORDBO revised the notes to SC of the term “emerging pest” and explained the changes to the TPG. He explained that the changes proposed after the face-to-face meeting are both to provide the SC additional procedural details and to simplify the text and avoid repetition.

[29] The TPG proposed some additional editorials changes at the meeting.

#### ***“visual examination” (2022-001)***

[30] No comments were provided after TPG meeting in Santiago.

[31] The draft 2023 amendments to ISPM 5 are provided as appendix 4 to the TPG December 2022 meeting report.

[32] The TPG:

(4) *agreed* to the changes;

(5) *finalized* the draft 2023 amendments to ISPM 5, which will be presented to the SC.

## **7. Ink amendments**

### **7.1 Proposals made by the LRG for Arabic and Chinese Coordinators**

[33] The secretariat presented the comments received by the Chinese and Arabic Language Review Groups.

[34] The TPG members for Arabic and Chinese languages agreed with the comments.

[35] The TPG:

(6) *agreed* with the suggestions from the Chinese and Arabic Language Review Groups.

## 8. TPG Work Plan 2023-2024

- [36] The secretariat presented the updated work plan with the applied changes decided during the TPG meeting in December 2022.
- [37] The TPG members proposed several additional changes to it.
- [38] One question was raised regarding the task “Check accuracy of translation of definitions in draft ISPMs and propose translations for Chinese, Arabic and Russian”. Draft ISPMs, except for ISPM 5, are translated only for first consultation in French and Spanish, and in all six FAO languages for adoption.
- [39] It was noted that the TPG does not check the accuracy of translation of the definitions in draft ISPMs but it rather reviews translation comments received from first consultation and provides suggestions to stewards and FAO Translation Services.
- [40] With regards to draft amendments to ISPM 5, the TPG proposes translation of the terms going for 1<sup>st</sup> consultation” and reviews translation comments and provides suggestions to FAO Translation Services before the draft amendments to ISPM 5 are submitted for 2<sup>nd</sup> consultation.
- [41] TPG also confirmed that members for each language check the translations of draft Amendments going for adoption (i.e. after SC November and when it has been revised/translated into all languages).
- [42] In this regard, relevant changes were made to the TPG work plan.
- [43] The TPG agreed that the Annotated Glossary should be published in 2024.
- [44] Then the TPG revised the Table with the terms and the subjects on the TPG work programme and proposed several editorial changes to further detail the decisions taken over time and changed the statuses accordingly. ”
- [45] The revised TPG Work Plan 2023-2024 was appended to the TPG December 2022 meeting report as Appendix 8.
- [46] The TPG:
- (7) *agreed* with the changed proposed during this meeting.

## 9. Any other business

### 9.1 IPPC Brochure on introduction to phytosanitary terminology

- [47] It was concerted that Mr RAMARATHNAM sends to the secretariat the missing part by 15 April and the TPG members submit their comments by 30 April.
- [48] The TPG agreed to:
- (8) *update* the IPPC Brochure on introduction to phytosanitary terminology and asked Secretariat to submit it for next step for publishing.

## 10. Date and type of next meetings

- [49] The next meeting of the TPG is scheduled from 27 November to 1 December 2023, with the venue tentatively agreed as FAO headquarters in Rome, Italy.

## 11. Close of the meeting

- [50] The secretariat thanked the TPG members for their contributions to the work of the TPG.
- [51] The chairperson thanked everyone and closed the meeting.

The TPG is requested to consider the below-listed comments made by the LRG Coordinators for Chinese and Arabic, respectively, as to what relates relevant language versions of ISPMs (including PTs).

<p>Comments from Mr Xiaoliang WANG, Chinese Language Review Group Coordinator</p>	<p>We find the "irradiation" was translated to "辐射" this time and this is not in line with the defining in ISPM 5 where the formal translation of "irradiation" should be "辐照".</p> <p>We have also reviewed the previous translation and we find some are correct and some are not.</p> <p>So could the FAO-Translation Services pay attention to this definition in the future translations?</p> <p>Could IPPC Secretariat make all the previous Chinese version of "irradiation" all in line with the correct definition "辐照" in ISPM 5?</p>
