Gratitude to donors

- [1] In 2023, the Implementation Facilitation Unit (IFU) of the IPPC Secretariat managed eight projects with a total value of over eight and a half million USD. Implementation of three of these projects will be active in 2024. Details about the five projects completed in 2023, and information on the three ongoing projects, are outlined in Appendix 1.
- [2] The IPPC Secretariat heavily relies on extrabudgetary funds and is expresses deep gratitude for the generous support on various projects from China, the European Union, Japan, the Common Market for Eastern and Southern Africa Secretariat (COMESA) Secretariat, USAID and GIZ.
- [3] The IFU is composed of experienced and dedicated professionals from all over world who diligently implement these projects, delivering agreed outputs with high quality products while meeting FAO procedure requirements. Other implementation and capacity development activities are conducted through in-kind contributions of personnel and through direct financial contributions from contracting parties to the IPPC Secretariat, as elaborated in the financial and annual report. The IPPC Secretariat expresses gratitude for the support and resources provided by Canada, France and the Republic of Korea.

Projects managed in full compliance with existing frameworks and strategies

- [4] The IPPC Secretariat primarily focuses on implementing projects with regional and global impact, with the exception of Phytosanitary Capacity Evaluations (PCEs), which are predominantly carried out at the national level. The implementation of these projects is embedded within and fully compliant with the IPPC frameworks and strategies and the Implementation and Capacity Development Committee (IC) procedures, namely:
 - The text of the IPPC,
 - The IPPC Strategic Framework 2020-2030, in particular for the implementation of the Development Agenda Items (DAIs) and the PCEs,
 - The Phytosanitary Capacity Evaluation Strategy 2020-2030, agreed upon by the IC and noted by CPM-16 (2022),
 - The IPPC List of Topics, for the development of guides and training materials.
 - The FAO South-South and Triangular Cooperation in action, for one of the projects embedded in this framework.
- [5] While the IPPC Secretariat manages these projects, it seeks endorsement from the IC for any new projects and updates the IC on project progress. Technical input is sought from the IC, when necessary,

as requested by the Bureau in 2018,¹ and in accordance with the *Strategy and process on how the Implementation and Capacity Development Committee (IC) reviews and analyses Implementation and Capacity Development (ICD) projects,* agreed by the IC in May 2019.²

[6] Additionally, the IPPC Secretariat administers and coordinates the delivery of PCEs by offering support to FAO and other donors' projects. The paper CPM 2024/29 provides a detailed update on activities related to PCEs.

A strong project management team built within the IPPC Secretariat

[7] Project management represents a large activity for IFU, encompassing project planning, monitoring, reporting, staffing, the issuance of purchase orders, staff management and the development of resources in coordination with the IC, IC sub-groups and IC teams. The list of IFU staff is frequently updated and is available on the IPP.³ The IFU annual workplan is also available on the IPP⁴ and reflects the important synergies between projects and the IPPC List of Topics under the IC guidance.

Projects implemented in transparency

- [8] Transparency with the wider IPPC Community has been enhanced through dedicated webpages⁵ for individual ICD projects managed by the IFU. These webpages include the identification code, title, start and end date of the project, budget details, a description of the project, and clear deliverables. A separate webpage was set for all projects over USD 500,000.
- [9] Furthermore, an annual call is issued on the IPP by the IPPC Secretariat to collect worldwide phytosanitary projects from contracting parties, RPPOs, FAO offices, donors, and implementing organizations. The IC analyses and discusses the relevance of the submitted projects, to be presented during the May meeting of the committee. Following the practice initiated in the IC May 2022 meeting, in 2023, the dedicated session of the IC meeting where projects were presented, was opened to the wider public in a webinar format.⁶
- [10] The CPM is invited to:
 - (1) *note* the deliverables of projects managed by the IPPC Secretariat;
 - (2) *note* the projects are compliant with IPPC Secretariat and IC procedures and the increased transparency as presented in Appendix 1.
