
- Regional Agricultural Health and Food Safety Policy and Action Plan

Regional Priority Pest List-2024

- 1. *Ceratitis capitata* (Mediterranean fruit fly)
- 2. Fusarium oxysporum f.sp. cubense TR4 (Tropical Race 4)
- 3. Trogoderma granarium (Khapra beetle)
- 4. Drosophila suzukii (Spotted-wing drosophila)
- 5. Dickeya dadantii (Bacterial soft rot)
- 6. Bursaphelenchus cocophilus (Red ring nematode)
- 7. Tomato brown rugose fruit virus
- 8. Megalurothrips usitatus (Bean thrips)
- 9. Candidatus Phytoplasma aculeata (Cactus phytoplasma)
- 10. Maize lethal necrosis disease (Virus)
