IPPC CONTRACTING PARTIES PLEDGED CONTRIBUTIONS AT CPM-19

The following IPPC Contracting parties pledged the following contributions at CPM-19 and in 2025:

Financial contributions:

Australia – AUD \$350,000 (USD 221,000)

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL):
 - o AUD \$75,000 earmarked for delivery of a workshop on Systems Approaches
 - o AUD \$75,000 earmarked for the development of two guides on authorising third parties audit and audit in the phytosanitary context
 - o AUD \$50,000 as unearmarked funds
- To the ePhyto Multi Donor Trust Fund (GCP/GLO/1304/MUL):
 - o AUD \$37,500 Australia's annual voluntary contribution to ePhyto solution 2025
 - o AUD \$37,500 Australia's annual voluntary contribution to ePhyto solution 2026
 - o AUD \$75,000 additional funds to support the ePhyto solution

The official letter from Australia was received on March 17^{th} and IPPC Secretariat replied by accepting the funding on March 18^{th} .

Canada - CAD \$290,000 (USD 202,000) - already received

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL):
 - o Funding of an Expert Working Group meeting for the development of a draft annex to International Standard for Phytosanitary Measures (ISPM) No. 47 on Audit in the Phytosanitary Context on remote audits (CAD \$80,000)
 - o Funding for finalizing the development of the guide to support the implementation of ISPM 47 Audit in the phytosanitary context (CAD \$65,000)
 - o Funding to ensure the continuation of the IPPC e-phyto solution (CAD \$85,000)
 - o Funding for the IPPC Technical Panel on Commodity Standards (CAD \$60,000)

The official letter from Canada was received on February 13th, and IPPC Secretariat replied by accepting the funding on February 19th. Funding also announced at CPM-19.

New Zealand - NZD \$100,000 (USD 58,000)

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL): NZD \$50,000
 - Funding the meeting of the Technical Panel of the Commodity and Pathway Standards in New Zealand
- To the ePhyto Multi Donor Trust Fund (GCP/GLO/1304/MUL); NZD \$50,000

CPM-19 contributions

United Kingdom – USD 1.2 million

- To the Africa Phytosanitary Programme (APP) project (GCP/GLO/1252/UK)
