



PROCEDURE TO BECOME A CONTRACTING PARTY TO THE INTERNATIONAL PLANT PROTECTION CONVENTION (IPPC)

Ratification and Adherence; Article XVII of the IPPC

- [1] The purpose of this document is to highlight the processes put in place for adherence of non-signatory states and member organizations of Food and Agriculture Organization (FAO) to the International Plant Protection Convention (IPPC). This paper outlines actions to be followed by both the government of a country considering adherence and the FAO and also provides a template of the instrument of adherence and steps to be followed by the IPPC upon finalization of the adherence process.
- [2] Article XVII (2) of the International Plant Protection Convention states “as soon as it came into force in accordance with Article XXII in April 1952, it shall be open for adherence by non-signatory states and member organizations of FAO”.
- [3] Accordingly, the government of a country considering adherence to the IPPC, submits its original **Instrument of Adherence** (including original signature and national stamp) on national letterhead to the Director General of Food and Agriculture Organization (FAO) of the United Nations, Viale delle Terme di Caracalla, 00153 Rome **Italy**. A model letter for member governments considering adherence to the Convention is attached to this document as *Appendix 1*.
- [4] The Adherence is effected when the request of the adherence (the instrument of adherence) from the country is deposited with the Director General of FAO and the DG notifies the country and ministers (Foreign Affairs and Agriculture) of the date of entry into force.
- [5] The DG will inform each signatory states (contracting parties) of the deposit of this instrument by the said country.
- [6] The instrument will be registered with the Secretariat of the United Nations in conformity with Article 2 of the Regulations to give effect to Article 102 of the Charter of United Nations adopted by the General Assembly as at present in force.
- [7] FAO internal procedure will include posting in NPPOs depositary in FAO Legal Page under FAO Treaties Database and informing internal divisions and units including the IPPC Secretariat.
- [8] The IPPC Secretariat updates the Country page in the IPP to change it from non-contracting party to contracting party and posts a news item about the new Contracting party.
- [9] The IPPC Secretariat has a link on top of the NPPOs page (<https://www.ippc.int/en/countries/nppos/list-countries/>) to the FAO legal page with all details of entry into force of countries: <https://www.fao.org/treaties/results/details/en/c/TRE-000013/>
- [10] The IPPC Secretariat will inform the country about its obligations under the Convention including National Reporting Obligations, description of the NPPO, nomination of IPP editor and Official Contact Points and other obligations.
- [11] Additionally and in accordance with **Article XVII (3)**, a member organization of FAO becomes a contracting party to this Convention, the member organization shall, in accordance with the provisions of **Article II paragraph 7** of the FAO Constitution (**distribution of competent**), as appropriate, notify at the time of its adherence such modifications or clarifications to its declaration of competence submitted under **Article II paragraph 5** of the FAO Constitution when applying for membership of this Convention.
