## I. Historique

1. À sa onzième session (2016), la Commission des mesures phytosanitaires (CMP) s'est prononcée pour que le Cadre relatif aux normes et à la mise en œuvre soit actualisé et géré par le Secrétariat de la Convention internationale pour la protection des végétaux (CIPV), et pour que son examen et sa modification relèvent conjointement du Comité des normes et du Comité chargé de la mise en œuvre et du renforcement des capacités, après examen par le Groupe de la planification stratégique. Elle a en outre décidé que le Cadre actualisé serait présenté tous les ans à la Commission afin qu'elle l'approuve.

2. En 2017, le Groupe de la planification stratégique a suggéré qu'il fallait encore améliorer la structure du document. Le Comité des normes et le Comité chargé de la mise en œuvre et du renforcement des capacités ont désigné des spécialistes chargés d'examiner la version actuelle du Cadre et d'en réviser la structure pour améliorer la lisibilité et la consultation.

3. Lors de leurs réunions de mai 2019, les membres du Comité des normes et du Comité chargé de la mise en œuvre et du renforcement des capacités ont examiné le nouveau format et les mises à jour du contenu du Cadre relatif aux normes et à la mise en œuvre, conformément au projet de Cadre stratégique de la CIPV pour 2020-2030. Ils ont approuvé le Cadre relatif aux normes et à la mise en œuvre et l'ont recommandé au Groupe de la planification stratégique.

4. Les membres du Groupe de la planification stratégique ont examiné le Cadre relatif aux normes et à la mise en œuvre en 2019 et ont recommandé à la CMP de l'approuver à sa quinzième session (2021).

5. La CMP est invitée à:

- 1) *approuver* la proposition de révision du Cadre relatif aux normes et à la mise en œuvre, telle qu'elle figure à l'annexe 1 du présent document;
- 2) *demander* au Secrétariat d'actualiser le contenu du Cadre relatif aux normes et à la mise en œuvre et d'y inclure les décisions prises par la CMP à sa quinzième session (2021);
- 3) *décider* que la version la plus récente du Cadre relatif aux normes et à la mise en œuvre, mise à jour par le Comité des normes, le Comité chargé de la mise en œuvre et du renforcement des capacités et le Groupe de la planification stratégique, sera conservée sur le Portail phytosanitaire international (PPI), où elle pourra être consultée dans son intégralité.

## Annex 1: Framework for Standards and Implementation, updated by SC May 2019 and IC May 2019, reviewed by SPG 2019

### 1. What is the Framework for Standards and Implementation?

The Framework for Standards and Implementation is a database of existing or proposed standards and tools for implementation aligning with the IPPC Strategic Framework for 2020-2030 (draft) in order to enable the identification of gaps as guidance for the development of standards and implementation materials to support implementation of the Convention, standards and CPM recommendations.

### 2. Objective of this document

The Framework provides transparency of existing or proposed standards and tools for implementation and helps identify gaps capturing the CPM priorities in order to guide inclusion of submitted topics into the list of topics for IPPC standards or Implementation and Capacity Development topics.

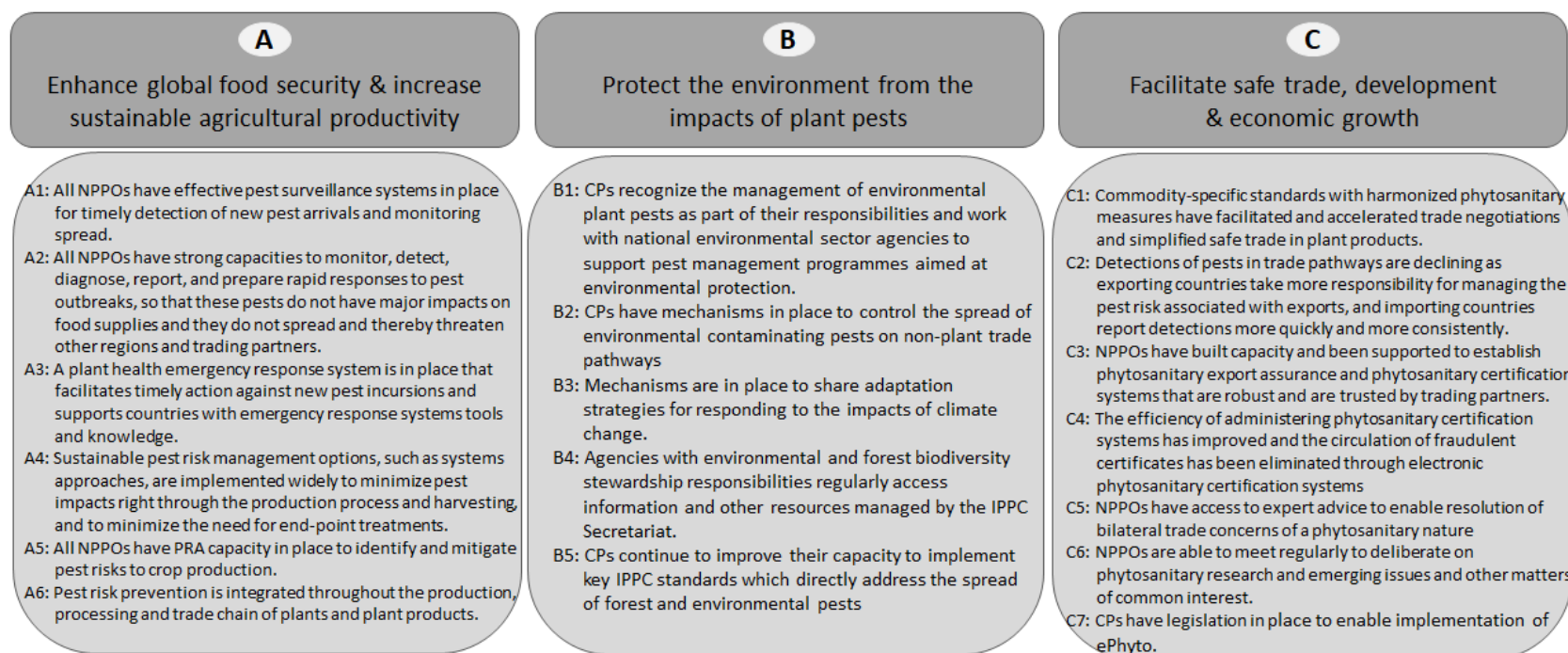
