## Agenda Item 6 of the Provisional Agenda

The FAO Conference was the Governing Body of the IPPC until the 1997 amendments 1. came into force. In Resolution 12/97, adopted at its 29th session, the FAO Conference established the Interim Commission on Phytosanitary Measures (ICPM) and delegated part of its responsibilities to the Interim Commission. Decisions taken by the FAO Conference and the ICPM are valid until the CPM decides otherwise.

2. The ICPM ceased to have the functions of a Governing Body after the coming into force of the 1997 amendments of the IPPC, and its subsidiary bodies will also cease to meet. Accordingly, decisions relating to the functioning of the ICPM, the establishment of subsidiary bodies and their functioning are of no consequence to the CPM. The CPM will have to adopt its own Rules of Procedure and will have to establish its own subsidiary bodies and their terms of reference, rules of procedure, and membership.

Annex 1 gives the list of ICPM decisions that continue to be of relevance after the FAO 3. Conference/ICPM ceases to be the Governing Body of the IPPC. It is understood that editorial changes are required to reflect the change from ICPM to CPM. For decisions that have to be taken by the CPM, a reference to the relevant agenda item, instead of a reference to the appropriate ICPM decision, has been provided.

4. The headings follow those of the Strategic directions (except for decisions on RPPOs, which are made a separate section) and their arrangement follows that of the Procedural Manual. The sections are:

- Administrative framework
- Standard setting
- Information exchange
- Dispute settlement \_
- Technical assistance \_
- Cooperation with relevant international organizations
- **Regional Plant Protection Organizations (RPPOs)**
