# **Trust Fund for the IPPC:** Financial report 2006

## Agenda Item 10.5.2 of the Provisional Agenda

#### I. **Provision of funds and expenditure over 2006**

1. In 2006 Canada, New Zealand and the United States made contributions to the Trust Fund for the IPPC. However as on past occasions, other voluntary contributions were made outside the Trust Fund for the IPPC for purposes similar to those that fall within the scope of the Trust Fund for the IPPC.

2. Details of revenue and expenditure of the Trust Fund for the IPPC are provided in Table 1 (annexed).

Expenditure from the Trust Fund for the IPPC in its third year of operation was much 3. higher than in the first and second years, with contributions to the CPM-1, to four Regional Workshops on draft ISPMs (two in Africa for French- and English-speaking countries, one for the Near East and one for Latin America), and to the meeting of the IPP Support Group organized in Wageningen (partly funded by the Netherlands government).

In the light of the limited resources available to the IPPC for the implementation of the 4. work programme for 2007, members are encouraged to provide substantive contributions to the Trust Fund for the IPPC to enable the goals of the IPPC business plan to be realised.

- 5. The CPM is invited to:
  - 1. *Note* the contributions to the Trust Fund for the IPPC as submitted in Table 1;
  - 2. Accept the expenditures against the Trust Fund for the IPPC provided in Table 1;
  - Thank the Governments of Canada, New Zealand and the United States for their 3. contributions to the Trust Fund for the IPPC;
  - 4. Encourage contracting parties to contribute to the Trust Fund for the year 2007.
