Composition of CPM Bureau and Subsidiary Bodies

Agenda Item 15 of the Provisional Agenda

I. INTRODUCTION

1. At its first session in 2006, the CPM elected a Bureau and established two subsidiary bodies, the Standards Committee and the Subsidiary Body on Dispute Settlement. CPM confirmed the membership for those subsidiary bodies. In addition, it confirmed potential replacements for members of the Standards Committee.

II. BUREAU OF THE CPM

2. The Rules of Procedure of the CPM (Rule II) requires the election of a Chairperson and not more than two Vice-Chair persons (the Bureau) at the end of the regular session of the CPM to hold office for a term of two years. The Bureau was elected at the end of CPM-1, and the next elections will be held at the end of CPM-3 in 2008. The composition of the Bureau is given in Annex 1.

III. STANDARDS COMMITTEE MEMBERSHIP AND POTENTIAL REPLACEMENT

3. In 2006 one Standards Committee (SC) member failed to attend two consecutive SC meetings and another two members resigned. As a consequence, two SC members from the Africa and North America regions have been replaced by individuals previously confirmed by the CPM as potential replacement for their respective regions, and one potential replacement from the Near East region needs to be transferred to the SC. These new members will complete the existing terms of the SC member they are replacing. The current membership of the Standards Committee and the list of potential replacements are given in Annex 2-A and 2-B respectively.

For reasons of economy, this document is produced in a limited number of copies. Delegates and observers are kindly requested to bring it to the meetings and to refrain from asking for additional copies, unless strictly indispensable.

4. Due to the transfer of potential replacements to the SC membership, there are now three vacant positions for potential replacements. Three regions (Africa, Near East and North America) may nominate one potential replacement each. In addition, in accordance with Rule 2 of the Rules of Procedures of the Standards Committee, FAO regions should also indicate the order in which potential replacements would serve as replacements. Letters have been sent to the Chairs of each of these three FAO regional groups requesting nominations be submitted to the IPPC Secretariat.

5. The CPM is invited to:

1. Note the current membership of the Standards Committee as shown in Annex 2-A and the potential replacements for the Standards Committee as shown in Annex 2-B.
2. *Confirm* new potential replacements, as appropriate;
3. *Confirm* the order in which potential replacements will be called upon for each region.

IV. SUBSIDIARY BODY ON DISPUTE SETTLEMENT MEMBERSHIP

6. Rule 2 of the Rules of Procedure of the Subsidiary Body on Dispute Settlement (SBDS) states that members of the Subsidiary Body on Dispute Settlement serve for terms of two years, with a maximum of six years. The SBDS membership was confirmed at CPM-1 in 2006, and is given in Annex 3.

7. Some modifications to the SBDS Rules of Procedure will be discussed under agenda item 12.2 (document CPM 2007/12). If the new rule regarding replacement of members is adopted, each FAO region may submit a nomination for a potential replacement for the SBDS.

8. The CPM is invited to:

1. *Note* the current membership of the SBDS as shown in Annex 3;
2. *Confirm* the new potential replacements, as appropriate depending on the outcome of discussions under agenda item 12.2.
