#### Open-Ended Working Group on IPPC Electronic Certification

I am pleased to announce that arrangements for the Open-Ended Working Group (OEWG) on IPPC Phytosanitary eCertification are being finalized, and formally invite you to nominate up to two participants per contracting party to attend this meeting. The Working Group will convene in Seoul, Republic of Korea, from 07 to 10 June, 2011. This meeting will be held in English only.

The programme for the open-ended working group is attached (Attachment 1) - participants can find the programme and additional information will be posted on the IPP (<a href="https://www.ippc.int">https://www.ippc.int</a>) as it becomes available. Due to resource restrictions, the Commission for Phytosanitary Measures (CPM) has agreed that there will be a limit of only 2 participants from each contracting party. To maximise benefits from this workshop it is strongly recommended that one participant should have IPPC regulatory expertise and the second participant IT / computer programming / systems analyst type expertise (it would be highly beneficial if the second expert also understands plant protection and in particularly the IPPC framework).

Participants are expected to fund their own travel and accommodation expenses. Those who wish to attend but cannot fund themselves are encouraged to approach donors for financial assistance. Very limited resources exist to assist some participants from developing countries with travel costs. Participants who believe they are eligible for this assistance may submit a request directly to the Secretariat (Tanja.Lahti@fao.org) no later than 06 May 2011. In all cases, the final determination regarding assistance is determined by the IPPC Secretariat. Participants are requested to make travel arrangements to arrive before the meeting begins (09:00 Tuesday 07 June 2011) and depart after the meeting ends (17:00 Friday 10 June 2011). All participants are requested to confirm their participation directly to Ms Tanja Lahti (Tanja.Lahti@fao.org) no later than 12 May 2011 in order to finalize local arrangements.

Regrettably, the IPPC Secretariat is unable to make hotel arrangements for participants attending the meeting. Participants will be provided further meeting and location details once they confirm their participation.
