Status of ISPM 15 Implementation

I. Background

1. At CPM-7 (2012) the Secretariat presented a report on the status of registration and renewal of registration of the ISPM 15 symbol. It also ran an evening session at which the FAO Legal Office explained the implications of not registering the symbol and the processes that countries can take to register the symbol. In its report to CPM-7, the Secretariat explained that financial resources were not available from FAO or IPPC to register the ISPM 15 symbol in additional countries. The Secretariat advised contracting parties of the due dates for the renewal of the registration under the systems currently used to register the symbol and that they should take this into account for their appropriate action.

2. The CPM considered the Secretariat's report. However, there were no proposals for alternative options for funding the registration of the ISPM 15 symbol. The CPM agreed that the Secretariat and FAO Legal Office should consider the possibility of registering the symbol with the World Intellectual Property Organization (WIPO) under article 6*ter* of the Paris Convention for the Protection of Industrial Property¹.

II. Current Status

3. In its feedback to the Secretariat, WIPO advised that it was not possible to register the ISPM 15 symbol under the WIPO system mentioned above.

4. At its meeting in October 2012, the Bureau discussed the matter of protection of ISPM 15 symbol and suggested that it be kept on the agenda of CPM to stimulate further discussion. In

addition, the Bureau suggested that consideration be given to planning for a further Question & Answer forum or side-session of the CPM to which FAO Legal Office would be invited.

5. On 6 December 2012 the Secretariat posted information on the International Phytosanitary Portal (IPP) to advise contracting parties of the need to engage in the process of securing the protection of the ISPM 15 symbol in their territories.

6. The status of registration and the due dates for renewal in various contracting parties are summarized in attachments 1 and 2 respectively.

- 7. The CPM is invited to:
 - 1) *note* the developments in regard to registration of the ISPM 15 symbol;
 - 2) *encourage* contracting parties to actively pursue the process of national registration of the ISPM 15 symbol;
 - 3) *encourage* contracting parties to renew registrations that are due to expire soon;
 - 4) suggest ideas for ensuring that protection of ISPM 15 symbol is guaranteed.
