**Subject: Change of Format on Thailand Phytosanitary Certificates**

I am writing this letter to inform you that the Department of Agriculture (DOA) as National Plant Protection Organization (NPPO) of Thailand has revised the format of Phytosanitary Certificate and Phytosanitary Certificate for re-export. Previously, the e-Phyto system has been issued Phytosanitary Certificates in original format. While the updated one will be changes as following:

- a. It will be printed on white bond paper, A4 size.
- b. The PC number will be changed to ten-digit code number, for example THXXXXXXXXXX, where by
  - TH means Thailand
  - The first and second digit will specify numbers representing the year with last two digits of the Buddhist era
  - The third and the fourth digit will specify numbers representing the months of the year
  - The last six digit is the serial number of the Phytosanitary Certificate issued in order
- c. A unique QR code will be added on the top-left corner of the Phytosanitary Certificate which will enable your inspectors to verify the documents more conveniently.

From the 1 August 2022 to 30 September 2022, the current phytosanitary certificate format and the new format will be used. As of the 1 October 2022,

only the new format of the phytosanitary certificates will be issued. Specimens of the new format of the Phytosanitary Certificate for export and Phytosanitary Certificate for re-export are attached in sample format for your reference.

I would like to take this opportunity to respectfully request that you notify your inspection staff on the new changes of the Phytosanitary Certificates in order to avoid any disruption of trade.
