CONCEPT NOTE

Background

The Commission on Phytosanitary Measures (CPM, Commission) is a FAO Statutory Body and serves as the governing body of the International Plant Protection Convention (IPPC).

The Commission normally meets once a year, in March or April, at FAO headquarters in Rome. The purpose of the meeting is to promote international cooperation, to review the state of plant protection around the world, to adopt international standards and other international recommendations, and to support implementation of the objectives of the IPPC.

The CPM orientation session is designed to support participants attending the CPM meeting. It is aimed at individuals attending CPM for the first or second time and those unfamiliar with the International Plant Protection Convention (IPPC) and its activities. The orientation session is also expected to provide helpful tips of interest to experienced CPM participants.

The orientation session will include interpretation in all FAO languages.

Expected Outcomes

The CPM orientation session is expected to enhance participation in CPM meetings by achieving the following outcomes:

- raised awareness about the IPPC and its main activities, and the governance structures in place to support the implementation of the IPPC;
- increased knowledge about what takes place during CPM;
- improved understanding of the key rules of procedure for participating in CPM and how to make interventions;
- increased knowledge about how to prepare to attend CPM; and
- improved understanding of the importance of following up on key outcomes from CPM after returning home and throughout the year.
