#### 1. Opening of the Meeting

[1] Mr Ralf LOPIAN, Chairperson of the IYPH International Steering Committee (ISC), welcomed all participants to the last meeting of the IYPH ISC and thanked them for their active engagement over the past twenty months.

#### 2. Adoption of the Agenda

- [2] The IYPH ISC Chairperson noted one request to discuss the maintenance of informal channels of communication on plant health beyond the International Year and this item was included under Any Other Business.
- [3] The Provisional Agenda was shared, adopted and is attached to this report as Annex 1.

#### 3. Participants List

[4] The Participants List is attached to this report as Annex 2.

#### 4. IYPH Legacies

#### 4.1 IYPH Webinar Series

- The IYPH Secretariat recalled the discussion that took place at the seventeenth IYPH ISC meeting suggesting a brainstorming session to be held regarding the topics for the two planned events of the IYPH Webinar Series of October and December 2021.
- [6] The IYPH ISC agreed to hold one webinar on remote sensing in plant health in October, with the support of EPPO and Euphresco. The IYPH ISC Chairperson encouraged the participation of diverse speakers on this matter for a wider perspective on this important topic.
- The IYPH ISC also agreed to hold the second webinar on for the importance of plant health for the UN 2030 Agenda, with the objective to advocate for the inclusion of a plant health-related indicator in the SDGs, noting the linkages with the current work of the IPPC Secretariat and FAO in relation to the United Nations Food Systems Summit, and the upcoming Data work stream of the Committee on World Food Security, among others.
- [8] The IYPH ISC asked the IPPC Secretariat to organise the two IYPH webinars with the support of the IYPH Technical Advisory Board.
- [9] The IYPH ISC:
  - (1) Agreed to hold two events of the IYPH Webinar Series: paving the way for the International Plant Health Conference on remote sensing in plant health (October 2021) and on the importance of plant health for the UN 2030 Agenda, with the objective to advocate for the inclusion of a plant health-related indicator in the SDGs.

#### 4.2 International Day of Plant Health

- [10] The IYPH Secretariat recalled that the Committee on Agriculture, the Council and Conference of FAO endorsed the proposal to establish the observance of an International Day of Plant Health (IDPH) on 12 May each year. The IYPH ISC discussed the most appropriate ways to keep oversight, coordination and management of this important initiative, which should take place during the week of the first International Plant Health Conference.
- [11] The IYPH ISC agreed that the IYPH Technical Advisory Board should become the new IDPH International Steering Committee, encouraging IYPH ISC members to volunteer to become members. Several IYPH ISC members suggested that the composition of the new IDPH ISC should also include IPPC and FAO regional representation alike, alongside the Rome-based Permanent Representatives to FAO.







- The IYPH ISC agreed that the newly-formed IDPH ISC should consider including also representatives from the private sector, the civil society and academia.
- [13] The IYPH ISC:
  - (2) *Agreed* that the IYPH Technical Advisory Board should become the IDPH International Steering Committee, with Rome-based Permanent Representatives to FAO as well as representatives from regions, private sector, civil society and academia.
  - (3) Asked the IPPC Secretariat to follow up with the appropriate process to develop Terms of Reference of the IDPH ISC with the involvement of the relevant FAO divisions.

#### 4.3 International Plant Health Conference

- [14] The IYPH ISC Chairperson updated the IYPH ISC briefly on the International Plant Health Conference, specifically on the host country, which may be the Republic of Ireland.
- [15] The IYPH ISC:
  - (4) *Asked* the IPPC Secretariat to liaise with the NPPO of the Republic of Ireland to confirm their potential availability to host the first International Plant Health Conference.

#### 4.4 IYPH Report

- The IYPH ISC Chairperson suggested that the IYPH Report should function as the last advocacy document of the IYPH to continue promoting plant health, also suggesting the IYPH Report may be ready by October 2021.
- [17] The IYPH Secretariat also provided a brief update regarding coordination process for the drafting, clarifying that some IYPH ISC members may be asked to provide quotes to be included in the report.
- [18] The IYPH ISC:
  - (5) Asked the IPPC Secretariat to lead the drafting process of the IYPH Report, to be published by October 2021.

#### 5. IYPH Communication

- [19] The IYPH Secretariat provided an update on the IYPH closing ceremony, clarifying that some plant-health communication products are still being developed with the IYPH advocates.
- [20] The IYPH ISC Chairperson noted that the positive outreach was an effective ice-breaker in bringing plant health to the general public.

#### 6. Any Other Business

The IYPH Secretariat informed that they came to know about the production of an IYPH commemorative stamp by Tonga, which raised the total number to twenty-nine IYPH stamps worldwide.

#### 6.1 Informal way to continue liaising on plant health

- [22] The IYPH Secretariat suggested to create a network for information exchange, composed of the current IYPH ISC membership, on plant health. May be using existing communication tools or think about new ones.
- [23] The IYPH ISC:
  - (6) Agreed to establish a Friend of Plant Health group to continue exchanging information on plant health-related issues.







#### 7. Close of the Meeting

- The IYPH ISC members expressed their appreciation towards the work delivered by the IYPH Secretariat and the IYPH ISC Chairperson's coordination, noting that the International Year of Plant Health has been highly successful.
- [25] Mr Ralf LOPIAN took the opportunity of this last IYPH ISC meeting to sincerely thank all IYPH ISC members, observers and FAO and IPPC staff members for their constructive, creative and professional contributions to the IYPH and the proceedings of this steering committee. He expressed his profound honour and privilege to have been associated with this IYPH ISC! He closed the meeting expressing his hope that the members of the IYPH ISC would continue to promote the notion that protecting plants is protecting life.
